Dear reader, we present the first edition of volume 14 of REUNIR Magazine. I would like to express my gratitude to the article evaluators, who demonstrated dedication to meeting deadlines and quality in preparing their opinions. To the authors of the eight published articles, I thank you for your diligence in constructing the work and improving it after the reviewers' evaluation.

The first article was written by **Júlio César Paes Silva** and **Gustavo Rodrigues Cunha**. The article aimed to analyze the sustainability configuration of the municipality of Porto Firme-MG, based on the allocation of public resources in the dimensions of the Minas Gerais Social Responsibility Index (IMRS), considering the social, environmental and economic-financial perspectives.

The second article is authored by **Bruna Camargos Avelino**, **Jacqueline Veneroso Alves da Cunha**, **Glaysson Aguilar de Araújo** and **Gerlando Augusto Sampaio Franco de Lima** and analyzed whether non-pathological traits of narcissistic personality in undergraduate students of Accounting Sciences and Controlling and Finance courses are related to the difficulty of these students in delaying immediate gratification.

The third article was produced by **Jéssica Vivianne da Cunha Silva de Brito**, **Josué Vitor de Medeiros Junior**, **Karen Aguiar Bezerra** and **Luan David Pereira do Nascimento**, who analyzed the use of the Life Cycle Canvas (LCC) technique in monitoring and control practices of fundraising projects for research infrastructure carried out within the scope of a Federal Higher Education Institution.

In the fourth article, **Luiz Henrique Vieira da Silva**, **Diego de Melo Conti**, **Cândido Ferreira da Silva Filho** and **Samuel Carvalho de Benedicto** explored how the Ecological Economy and global agendas for sustainable development, such as the 2030 Agenda, promulgated by member countries of the United Nations United in 2015, they can influence the reorientation of public policies at the subnational level.

The fifth article, authored by **Carlos Cândido da Silva Cyrne**, **Júlia Elisabete Barden**, **Fernanda Cristina Wiebusch Sindelar** and **Rafaela Danieli**, identified the impacts on the environment resulting from the production of organic cow's milk compared to conventional production.

The sixth article, produced by **Luanna Ematné de Matos**, **Nathália Santos Serrão de Castro** and **Giselle Maria Rachid Viana**, aimed to estimate the community's perception of the Evandro Chagas Institute (IEC), recognized as an Institute of Science and Technology (ICT) from the Ministry of Health (MS), on sustainability practices.

Rossana Guerra Sousa, **Adriana Fernandes de Vasconcelos** and **Leandro da Costa Santos** are the authors of the seventh article and the objective of the study was to provide initial evidence for the

Brazilian scenario about employees' Whistleblowing intentions, when multiple communication channels are available.

The last article in this edition belongs to **Gustavo Henrique Petean, Leonardo de Oliveira Dresch, Daniel Teotonio do Nascimento** and **Elcio Gustavo Benini**, and aimed to analyze how the classical approach to administration is captured in the academic manuals of this discipline.
